Strengthening relations with health centres for the development of innovation and the development of agreements with other institutions. To advice and collaborate for the planning and develop innovation projects in biomedicine and health. To dynamiser innovation among health researchers and innovators, coordinating the support of the Institute in the different health centres of the Institute, especially in specific calls for innovation.
